### How to Give

Talk to a member of the Ministry Team about volunteering your time – they will be delighted to hear from you.

Join our Planned Giving scheme – to demonstrate your commitment to God's work at St Mary's and enable the PCC to plan with confidence in the level of income available. You can give in three ways:

- The Parish Giving Scheme www.parishgiving.org.uk which, if you are a taxpayer, automatically claims back Gift Aid on your behalf.
- 2. Standing Order direct from your bank account.
- 3. Putting cash in weekly envelopes.

For many, I. and 2. are convenient ways to give and are much simpler for the church to administer.

If you are a UK taxpayer, please also complete a Gift Aid declaration, as this increases the value of your gift to the church by 25% – at no cost to you!

Please consider including a legacy to St Mary's in your Will. Such bequests reduce the value of your estate for Inheritance Tax purposes and therefore could effectively attract tax relief at up to 40%.

## **Our Needs**

St Mary's is dependant on the many volunteers who help to maintain the dayto-day functions of the church. Specialist skills are rarely needed: just a willingness to commit a little of your time and energy to sustain an area of parish life or to bring a particular project to fruition. What could you be doing to support St Mary's?

Each year, St Mary's aims to balance its budget so that the regular giving we receive matches our day-to-day living expenses and the upkeep of the church. This has proved to be challenging in recent years as our regular outgoings continue to exceed our regular income from Planned Giving. This has not been helped by a decline in membership of the Planned Giving scheme: would you be willing to join?

We have no Church Hall to let out so our only option to supplement our income is to hold regular fundraising events. Could you help organise or publicise any of these events?

# Your Gift

Your giving is your response to the gifts you receive from God. We are all called to love God and our neighbour and your giving, whether of money or of your time and talents, is an expression of that love.

There is no one right answer as to how much time or money each person might give. Your decision should be made prayerfully and depend on your particular circumstances. The General Synod has suggested that 5% of take home pay may be appropriate, but some people follow the biblical principle of tithing: giving 10%. Others determine their giving in relation to expenditure for example on hobbies, luxuries or essentials. Some people may struggle to give money but can give of their time in support of the work of the church

In summary, please :

- join Planned Giving if you are not already a member
- optimise your giving through Gift Aid
- consider your giving of time and/or money to your church
- give realistically in the light of your personal circumstances
- include St Mary's in your Will.
